RESOLUTION OF AUTHORIZATION OF RETIREMENT AND DONATION OF K-9 ‘YEFF’

WHEREAS, the Roscommon County Sheriff’s Department has previously established and maintains a K-9 Unit which consists of certain Deputies and Patrol Service Canines; and

WHEREAS, K-9 Yeff was purchased by the Roscommon County Sheriff’s Department for service in the K-9 unit and has reached an age in which it is physically necessary to retire and supplant him with an additional K-9; and

WHEREAS, the Constitution of the State of Michigan and Act 156 of 1851, Section 46.11 vests the Roscommon County Board of Commissioners with “the care and management” of “real and personal property” for the benefit of the County, including authority over determining usefulness and disposal of County property; and

WHEREAS, the former handler of K-9 Yeff has indicated a strong willingness to assume full responsibility and care, and is uniquely qualified to care for K-9 Yeff; and

WHEREAS, the fair market value of a ten year old patrol service canine is less than \$25.00;
