Special Meeting Minutes *June 22, 2020*

The Roscommon County Planning Commission met on Monday, **June 22, 2020** via ZOOM

David Russo made motion to approve the agenda as written, Tim Grahl seconded, motion carried.

Correspondence

- The Lake Township short-term rental ordinance draft was provided to the board.
- The question about whether it would supersede Ordinance #9 R1 & R2 was discussed. No conclusion was reached.
- Member David Russo cautioned Lake Township and said that the case “Phillips vs. Holt Drive, Lake Township” was lost by the neighborhood.
- Tony Farhat, Lake Township Trustee, stated that the ordinance was going to be delivered as a police ordinance rather than a zoning ordinance.
- The county planning commission decided to reserve judgement on the short-term rental ordinance since the matter is going before the Township Board (as a police ordinance) rather than the Planning Commission (as a zoning ordinance). In addition, the copy we were given had been amended after we received the initial draft.
- Member David Russo requested a copy be sent to the county planning commission prior to Lake Township voting on it.

New Business – Roscommon County Planning Commission Nominations

A motion was made by David Russo for Tim Grahl to be appointed to the Roscommon County Planning Commission for another three year term. The motion was seconded by Barb Stauffer. Motion carried.

A motion was made by Barb Stauffer for Chairman Julie Crick to be appointed to the Roscommon County Planning Commission for another three year term. The motion was seconded by David Russo. Motion carried.

Julie Crick made a motion to add Kirstie Russo to the Roscommon County Planning Commission. Barb Stauffer seconded the motion. Motion carried unanimously for Kirstie to serve a three year term.
