Holidays take precedence over regularly scheduled parenting time. When the holiday of the parent exercising alternating weekend parenting time supersedes that parent's weekend, that parent will receive the following weekend that is not part of the holiday or break. This will restart the alternating weekend cycle.

Extended parenting time may range from one week to three months, consecutive or not, based upon the parent/child relationship, child(ren)'s age, case history, court order and/or any other relevant factors. Extended parenting time is normally in the summer but may take place during the winter due to a parent's seasonal employment. Extended parenting time shall occur:
