THINGS TO KNOW ABOUT PROBATION WITH THE 82ND DISTRICT COURT-ROSCOMMON:

• **CASE NUMBER**: Found on the top right corner of your court documents.

• **REPORTING INFORMATION**: Until further notice, there is NO face to face reporting

- Probationers are reporting via the mail-in report document or by utilizing the CourtFact app/website <https://portal.courtfact.com/#/login> with their assigned Client ID.
- All monthly reporting is due by the 14th of each month.

• **DRUG/ALCOHOL TESTING**: You must pay for the test at the time that you are tested. If you have no money, fail to take a test, provide a diluted or adulterated specimen or test positive, you have violated your probation.

- **Local Testing Information**: *You must check in by 11:00 am Monday-Friday*
Call **800-494-1250** or go to www.drugtestcheck.com Enter your assigned client code and then 1st 4 letters of your last name. You will then be told to report to test or not.

Testing Location: 82nd District Court-Probation

Cost: Full panel-\$20; ETG-\$10; Lab confirm/substance \$30

Male Hours: Mon - Fri: 8:30 am-11:00 am **Female Hours**: Mon-Fri: 9:00 am-3:00 pm

**** NOTE**** If you don't test with the 82nd District Court at the scheduled time, you must submit to minimum of a **supervised 5 panel urine screen with ETG** at an **approved location**

• **NO CONTACT ORDERED AS A CONDITION OF PROBATION**: No contact means: **no contact of any kind!**

Including but not limited to: mail, email, text message, social media, face to face, 3rd party, and telephone.

• **COMMUNICATION**: Always be honest with the Probation Department. It's our role to ensure compliance with the Court's order; time and resources are wasted if you are not open and honest. THINGS TO KNOW ABOUT PROBATION WITH THE 82ND DISTRICT COURT-ROSCOMMON continued:

- **TREATMENT & PROGRAMS COMMONLY UTILIZED:** -Probationer's MUST sign a release of information with their treatment provider so that the Probation Department can communicate with the provider regarding progress and attendance. Failure to allow the provider and probation to communicate may result in a violation as participation cannot be confirmed.
 - **Community Service-** Hours may be completed with any non-profit 501C organization or government/public service entity, if you are unclear, speak with the Probation Department directly.
